WHEREAS:

- Rail transport of oil and ethanol across Minnesota continues at high levels due to North Dakota oil fields, ethanol production standards and Canadian tar sands;
- Trains carrying oil, ethanol and other high hazard freight (radioactive substances, chlorine gas, anhydrous ammonia) put at risk over 350,000 Minnesotans that live near these tracks as well as numerous bodies of water and environmentally sensitive areas;
- Significant catastrophes have resulted from the derailment of trains carrying hazardous materials;
- Laws and regulations governing rail safety are inconsistent and inadequate. The U. S. Federal Railroad Administration has raised concerns about structural integrity of train cars used to transport hazardous materials, aging rail infrastructure, train route selection, and the lack of industry liability coverage.
